**ANNOUNCEMENT ON ESTIMATED INCREASE IN THE RESULTS
FOR THE FIRST HALF OF 2024**

This announcement is made by Shandong Gold Mining Co., Ltd. (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 and Rule 13.10B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

IMPORTANT NOTICE:

After preliminary calculation, it is estimated that the Company will realise a net profit attributable to the owners of the parent company of RMB1,250 million to RMB1,450 million for the first half of 2024, representing an increase of RMB370 million to RMB570 million as compared with the corresponding period of the previous year, or a year-on-year increase of 42.07% to 64.81%.

It is expected that the net profit attributable to the owners of the parent company after deducting non-recurring gains and losses will be RMB1,280 million to RMB1,480 million for the first half of 2024, representing an increase of RMB399 million to RMB599 million as compared with the corresponding period of the previous year, or a year-on-year increase of 45.21% to 67.89%.

I. ESTIMATED RESULTS FOR THE PERIOD

(II) Estimated results

1. After preliminary calculation, it is estimated that the Company will realise a net profit attributable to the owners of the parent company of RMB1,250 million to RMB1,450 million for the first half of 2024, representing an increase of RMB370 million to RMB570 million as compared with the corresponding period of the previous year, or a year-on-year increase of 42.07% to 64.81%.

II. RESULTS FOR THE CORRESPONDING PERIOD OF THE PREVIOUS YEAR

- (1) The net profit attributable to the owners of the parent company was RMB880 million. The net profit attributable to the owners of the parent company after deducting non-recurring gains and losses was RMB882 million.
- (2) Earnings per share: RMB0.15.

III. MAIN REASONS FOR THE ESTIMATED INCREASE IN THE RESULTS FOR THE PERIOD

In the first half of 2024, the Company strengthened the role of strategic leadership, emphasized production organization, continuously optimized production layout, and enhanced technical management and technological innovation to improve the production operation rate and resource utilization rate. The Company continued further efforts on cost reduction and efficiency enhancement, elevated the standard of meticulous management and operational efficiency and stabilized production costs through technological innovation, process optimization, asset revitalization, centralized procurement and creation of benefits with policies. In addition, the continued rise in gold prices in the first half of 2024 and the acquisition of Yintai Gold also contributed to an increase in the Company's profits.
